4.0 Cadarnhau Cofnodion cyfarfod Mis Rhagfyr. / Confirmation of the accuracy of the minutes of the December Meeting.

Cynigiodd , y Cyng John Howells ac eiliwyd gan, Cyng Wyn Evans a cytunodd pob aelod fod cofnodion Mis Rhagfyr yn gywir. /

It was proposed by Cllr John Howells and seconded by Cllr Wyn Evans and all members agreed that the minutes of the December meeting were correct.

5.0 Materion yn Codi o'r cyfarfod diwethaf / Matters arising from the previous meeting .

a. Yn y cyfarfod diwethaf gofynnodd y Cyng Robert Newell os oedd unrhyw newyddion am osodiad arwyddion 40myh yn Mynyddcerrig a oedd wedi cael ei addo tipyn o amser yn ol . Roedd y clerc wedi ysgrifennu at Mr John McEvoy ac wedi debyn cydnabyddiaeth ond heb dderbyn ateb pendant./ At the last meeting Cllr Robert Newell asked if there was any news on the installation of the 40mph sign at Mynyddcerrig which had been agreed some time ago. The clerk had written to Mr John McEvoy to find out when the sign will be installed .

A holding reply was received from Mr John McEvoy but no substantive reply has been received to date .

b.Dyweddod y Cyng H V Williams ei bod wedi derbyn nifer o gwynion am y golau ar Heol Cwmisfael ,Llanddarog Cllr H V Williams informed that he had received numerous complaints with regard to the reduced intensity of lights on Cwmisfael Rd, Llanddarog .

Roedd y clerc wedi danfon e bost i CCC ac wedi derbyn ateb yn dweud:--The clerk had e mailed to CCC and had received a reply stating that :-

They have checked their database for any faults picked up on their night patrol & no faults have been reported along this road since September 2013, our night patrol was in the area on Monday night & nothing was picked up. There are a number of part night lights on this road, off at approx. 00:30 & back on approx. 05:30, but the part night lights were installed on 25th March 2011 so have been there for nearly five years. They ask if the council could provide further information as to exactly where on the road the complaints regarding the reduced intensity of lights are as all lanterns, lamps & cells have remained the same since September 2013.

CCC -- LOCAL AUTHORITIES (CALCULATION OF COUNCIL TAX BASE) (WALES) REGULATIONS 1995

Under the above Regulations CCC is required to inform Community Councils of the Tax Base for their area. This figure below will enable the council to translate the precept requirements into the Council Tax to be levied for a Band D property and to all other Bands.

The figure for Llanddarog Community Council for 2016/17 is **543.02**

Precept Requirement 2016/17

They inform that the relevant legislation, notice of your precept requirement for 2016/17 is required before 1st March 2016. However, in order to assist the County Authority with its own budget process, they would be obliged if Llanddarog CC could inform them of the Council's requirement before **31st January 2016** by completing and returning the precept form for 2016/17. If, due to the timing of your meeting cycle or any exceptional circumstances, your Council's precept requirement is not available by this date, please inform me of the figure by e-mail or telephone as soon as possible.

In any case, the completed form (including signatures) should be returned either by e-mail (scanned copy) to CJWilkins@carmarthenshire.gov.uk or by post (original) to: Carmarthenshire County Council, FAO Chris Wilkins, Accountancy Section, Corporate Services Department, County Hall, Carmarthen, SA31 1JP.

Once the form has been received, a confirmation will be sent.

The clerk and Cllr Robert Jones had met to compile a draft council budget plan for next year and at the same time looked at the precept required to meet the budget plan for 2016-17.

All councillors present were given a copy of budget plan and time was allocated to them to read and ask questions with regard to the proposed budget plan before discussing the precept requirement for 2016-17.

After some discussions and questions the Council unanimously accepted the 2016-17 budget plan.

Following on from the acceptance of the budget plan council discussed their precept requirement for 2015-16 taking account of the calculated/estimated budget figure of £16550 .

In order to meet the budget figure and allow for some unforeseen expenditure council agreed to set a precept figure of £16707 which equated to a 1% increase from the previous year and an increase on the Band D rate of 31p per year.
