31/3/18. Hefyd, maent am gwybod faint o Aelodau sydd heb gael unrhyw hyrfforddiant ar y Cod ers 1/4/15. Penderfynwyd nodi fod y Clerc eisoes wedi ymateb gyda'r nifer o ddatganiadau. O ran hyfforddiant o 1/4/17 tan 31/3/18, mae 2 o Aelodau wedi derbyn hyfforddiant. Ar ôl adborth o'r cyfarfod cyhoeddus ar 3/10/18, fe wnaeth Aelodau deimlo fod angen ail ystyried y lleoliad a ffafrir. Fe bwysleisiwyd pwysigrwydd sicrhau fod y gysgodfa yn hygyrch i bawb. O ran gwerth arian, roedd trafodaeth ar os oedd angen i'r Cyngor Cymuned gael dyfynbrisiau ysgrifenedig. Fe gyfeiriwyd beth bynnag at Reoliad ariannol 11.1(a)(ii) o ran fyddai'r Cyngor Sir yn darparu gwasanaeth arbenigol fel Awdurdod Priffyrdd (marcio heol, arwyddion ayyb) ac maent yn gwneud y gwaith dylunio 'mewn da (in kind)'. Mae'n debygol fe fydd y gysgodfa ei hun yn debyg i rai eraill maent yn doddi i fyny dros y Sir a fel corff cyhoeddus maent yn mynd i geisio cael gwerth gorau. Mae'n debygol taw y costau newidiol yn y prosiect yma fydd unrhyw beirianeg sifil -ee cyrbiau uwch – yn hytrach na'r gysgodfa ei hun. Fe wnaeth Aelodau gyfeirio at gytundeb adran 106 yn cael ei arwyddo ar gyfer y datblygiad tai arfaethedig gyferbyn Neuadd Llanddarog a taw'r Cyngor yma oedd yr ymgeisydd am gynaniad cynllunio amlinellol. Fe wnaeth y Clerc gynghori yn flin nad oedd ef wedi bod yn rhan o unrhyw nodwedd o'r cytundeb yma ar ran y Cyngor yma ers ymuno gyda'r Cyngor yma ym mis Mawrth 2016.

Fe benderfynwyd

- (a) Fe fydd adolygiad o safleoedd amgen yn cael ei wneud, i gynnwys y safle o dan y White Hart, gyda chyfyngiadau yn cael ei adnabod (ee ardal cadwraeth);
- (b) Fod trafodaeth ar bryderon y cyhoedd o ran llwybrau ac amseroedd gwasanaeth bysiau yn cael ei ddodi ar agenda cyfarfod mis Tachwedd 2018 y Cyngor.

/ Following feedback from the public meeting on 3/10/18, Members felt that the preferred location needed to be revisited. The importance of the shelter being accessible to all was stressed. In relation to value for money, there was discussion as to whether the Community Council needed to obtain written quotes. Reference was however made to financial regulation 11.1(a)(ii) in that the County Council would be providing a specialist service as Highway Authority (road markings, signage etc) and are already undertaking design work 'in kind'. The shelter itself is likely to be typical of other shelters they put up across the County and as a public authority, they are going to look for best value. The variables in this scheme are likely to be any civil engineering works– eg any raised kerbs as opposed to the shelter itself. Councillors referred to a section 106 agreement being signed for the proposed housing development opposite Llanddarog Hall and that this Council had been the applicant for outline planning permission. The Clerk regrettably advised that he has not been involved in any aspect of this agreement on behalf of this Council since joining this Council in March 2016.

It was resolved that

- (a) A review of alternative sites be undertaken, to include the land below the White Hart, with constraints identified (eg conservation area);*
- (b) That a discussion on the concerns of residents in relation to the bus service routes and times be listed on the agenda of the November 2018 meeting of the Council.*

Dylid nodi fe wnaeth yr adroddiad cadarnhau cywirdeb y cysoniad at y banc ac adroddiad y gyllideb a rhodddwyd i'r Cyngor ym mis Medi 2018 (yng Cofnod 122/2018-19). Fe wnaeth Cyng Jones hefyd ddweud ei fod wedi adolygu rhan ariannu (£750) gan y Cyngor Cymuned tuag at arwyddion newydd ym Mynyddcerrig. Roedd yn cynghori fod y Cyngor Cymuned yn rhoi ei rheoliadau ariannol at un ochr ar sail fod hwn yn wasanaeth arbennig yn cael ei ddarparu gan y Cyngor Sir yn ei rôl fel Awdurdod Priffyrdd (rheoliad 11.1(a)(ii)). Mae'r Cyngor Sir yn darparu a gosod yr arwyddion yn unol â manyleb sydd angen ac yn talu hanner y swm o £1,500. Fe fyddent hwy, fel corff cyhoeddus, yn ceisio cael gwerth gorau wrth ddarparu gwasanaethau. Penderfynwyd derbyn yr adroddiad a'r argymhellion a diolch i Cyng Jones a'r Clerc am ei gwaith. / *A full verbal report was provided by Cllr R Jones (Internal Financial Examiner for the Council). Also, each Member was provided with a written copy of his report in advance of the meeting. It should be noted that the report confirmed the accuracy of the bank reconciliation and budget report provided to Council in September 2018 (minute 122/2018-19 refers). Cllr Jones also stated that he has recently reviewed the part funding (£750) by the Community Council towards the cost of new signage in Mynyddcerrig. He is advising that the Community Council set aside its financial regulations on the basis that this is a specialist service provided via the County Council's role as Highway Authority (regulation 11.1(a)(ii)). The County Council are supplying and installing signage of the required specification and are paying half of the overall cost of £1,500. The County Council, as a public Authority, will be looking for best value when delivering services. It was resolved to accept the report and recommendations and thank Cllr Jones and the Clerk for their work.*
