Rhoddodd y Cyng. A Davies adroddiad lawn. Dywedodd, cyn belled â'i fod o fewn terfynau maint, ni fyddai angen caniatâd cynllunio ar gyfer lloches ger y White Hart, Llanddarog. Mae'n cynnig diwrnod casglu sbwriel a gofynnwyd i'r Cyngor a gellir ystyried hwn yn cyfarfod mis Mawrth 2019. Mae hi hefyd yn bwriadu cynnal syrjeri ac yn llunio cylchlythyr. Cytunodd yr Aelodau fod Pwyllgor Cyswllt Torcoed yn darparu fforwm ar gyfer pryderon traffig a godwyd ym Mynyddcerrig. Eglurodd ei sefyllfa mewn perthynas â'i safle ymgeisio Cynllun Datblygu Lleol. Fe fydd yr Aelodau yn cael CV yr archwiliwr mewnol, ynghyd a'r a'r cynllun archwilio / cwmpas arfaethedig ar gyfer 2018-19. Bydd y penodiad a'r cwmpas yn destun i gadarnhad y Cyngor. / *The Clerk has opened discussions with the current internal auditor, and he is interested in undertaking the internal audit next year. It was resolved to list this item on the agenda of the April 2019 Council meeting. Members will be provided with the CV of the internal auditor and the proposed audit plan / scope for 2018-19. The appointment and scope will be subject to Council's confirmation.*

Roedd yr Aelodau wedi derbyn yr adroddiad cyn y cyfarfod. Nodwyd yr argymhellion a wnaed o ran yr angen i ymhél a sedd 9 (Sgwâr Hibbard, Mynyddcerrig) ynghyd â'r angen i ymhél a'r polion faner ynghyd a'r lloches bws yn Llanddarog (peintio). Penderfynwyd byddai Cyng J Williams a'r Clerc yn cyfarfod â Mr Jones o Total Building Maintenance (TBM) er mwyn gytuno cost a'r amserlen ar gyfer y gwaith hwn. Penderfynwyd hefyd bod TBM i'w gyfarwyddo i fynd i ffwrdd â sedd 9 os mae TBM yn ei ystyried yn anniogel. / *Members had received the report in advance of the meeting. The recommendations made in respect of the need to attend to seat 9 (Sgwar Hibbard, Mynyddcerrig) along with the need to attend to the flag poles and the bus shelter in Llanddarog were noted (painting). It was resolved that Cllr J Williams and the Clerk meet with Mr Jones of Total Building Maintenance*

(TBM) to agree the cost and timeline for these works. Further resolved that TBM are to be instructed to remove seat 9 if TBM deem it unsafe.

275/2018-19 Cynigion Llywodraeth Cymru ar gyfer gwella'r fframwaith deddfwriaethol yng Nghymru ar gyfer cynllunio a darparu gwasanaethau bysiau lleol yng Nghymru, a hefyd ar gyfer diwygio'r drefn drwyddedu ar gyfer tacsis a cherbydau hurio preifat / Welsh Government's proposals for improving the legislative framework in Wales for how local bus services are planned and delivered, together with reform of the licensing regime for taxis and private hire vehicles (PHVs).

Mae'r Cyng J Williams wedi edrych ar hyn yn fanwl o rhan tacsis yn bennaf. Roedd yr ymdeimlad cyffredinol yn gadarnhaol, er ei bod yn bwysig bod agweddau allweddol (ee prisiau) yn cael eu penderfynu'n lleol. Mae'r Cyng Williams wedi drafftio ymateb ysgrifenedig ar ran y Cyngor. Cyngorodd y Cyng Williams hefyd am yr ymateb a dderbynwyd i'w arolwg ef ar brisiau tacsis. Penderfynwyd diolch i'r Cyng Williams ac fe fydd ei ymateb drafft yn cael ei ddsbarthu i'r holl Aelodau am unrhyw sylwadau trwy e-bost cyn iddo gael ei gyflwyno i Lywodraeth Cymru. / *Cllr J Williams has looked at this in detail, mainly in terms of taxis. The overall sense was positive, albeit it was considered important that key aspects (eg fares) should be determined locally. Cllr Williams has drafted a written response on behalf of the Council. Cllr Williams also advised on the response received to his survey on taxi fares. Resolved to thank Cllr Williams and for his draft response to be circulated to all Members for any comment via e mail ahead of it being submitted to the Welsh Government.*

Roedd yr Aelodau wedi derbyn polisi cadw dogfennau arfaethedig (a oedd yn cynnwys cyngor a dderbyniwyd gan Gymdeithas Clercod Cyngorau Lleol - SLCC) cyn y cyfarfod. Mae'r Cyng. E Davies yn parhau i edrych i ffurfio cytundeb(au) ysgrifenedig gyda prosesydd(wyr) data'r Cyngor. Dywedodd y Clerc fod gan y SLCC bolisi enghreifftiol o ddiogelu data a all fod yn sail i bolisi'r Cyngor. Penderfynwyd mabwysiadu'r polisi cadw dogfennau, yn ddarostyngedig i fân newidiadau teipograffyddol a dileu 'sieciau wedi talu' o'r atodiad. Bydd y contract(au) prosesu data a pholisi diogelu data arfaethedig yn dod gerbron y Cyngor maes o law. / *Members had received a proposed document retention policy (which included advice received from the Society of Local Council Clerks) in advance of the meeting. Cllr E Davies is continuing to look into formulating contract(s) with the Council's data processor(s). The Clerk stated that the SLCC has a model data protection policy which can form the basis of policy for the Council. Resolved that the document retention policy be adopted, subject to minor typographical amendments and deletion of 'paid cheques' from the appendix. The data processing contract(s) and a proposed data protection policy will be brought before Council in due course.*

Roedd yr Aelodau wedi derbyn copi o ohebiaeth gan drigolyn lleol i'r Cyngor ydd Sir yn gofyn beth oedd yn digwydd. Roedd y preswlydd yn deall bod Cyngor Cymuned Llanddarog wedi cytuno i ddarparu lloches bws newydd yn dilyn y cyfarfod cyhoeddus a gynhaliwyd yn Neuadd Llanddarog. Pwysleisiodd yr Aelodau fod Cyngor Cymuned Llanddarog wedi penderfynu

yn flaenorol fel pwynt o bolisi bod angen gwella darpariaeth lloches bws yn Llanddarog ac wedi clustnodi safle dewisol. Mae'r safle a ffafrir bellach yn cael ei adolygu, fodd bynnag, yn bennaf oherwydd pryderon ynghylch hygyrchedd (gan gynnwys yr angen i godi cyrbiau).
