Policing and Road Safety Matters

Mynegwyd pryderon fod marciau heol wedi pylu yn Mynyddcerrig, a hefyd fod arwydd "rhowch ffordd" ar goll ar "Cyffordd T" yn Llanddarog gyferbyn yr Eglwys. Hefyd, fe fynegwyd sylwadau cyffredinol o ran diogelwch yr heol wrth ddod i mewn i Fynyddcerrig o Gapel Seion. Penderfynwyd bod y Clerc yn codi'r pryderon hyn gyda'r Cyngor Sir. / *Concerns were expressed as to faded road markings in Mynyddcerrig, along with the missing give way sign at the T Junction in Llanddarog opposite the Church. General observations were made with regards to highway safety at the Capel Seion approach to Mynyddcerrig. It was resolved that the Clerk raise these concerns with the County Council.*

Ar ôl cynnig gan y Cyng R Jones ac eilio gan Cyng M Rees; penderfynwyd cadarnhau a llofnodi'r cofnodion (dan law'r cadeirydd llywyddol), yn amodol ar nodi dylid gwneud cywiriad ffeithiol i gofnod 271/2018-19 (gweler cofnod 298/2018-19 o'r cofnodion hyn mewn perthynas â siec(iau) 1425/1426). / *Following a proposal by Cllr R Jones and seconding by Cllr M Rees, it was resolved to confirm and sign the minutes (under the hand of the presiding chairman), subject to it being noted that a factual correction should be made to minute 271/2018-19 (see minute 298/2018-19 of these minutes in respect of cheques 1425/1426).*

(a) **Yng Cofnod - 266/2018-19(a)** - Cynhaliwyd yr hyfforddiant, gyda 5 o Gynghorwyr a'r Clerc yn bresennol. Penderfynwyd nodi'r hyfforddiant. Penderfynwyd ymhellach y dylai'r Clerc gael cyngor gan Un Llais Cymru ynghylch a ddylai'r Cyngor ystyried gohebiaeth a gyfeiriwyd ato os yw'n ddiennw. / ***Minute 266/2018-19(a) refers*** – *The training was held, with 5 Councillors and the Clerk in attendance. Resolved to note the training. Further resolved that that the Clerk attain advice from One Voice Wales as to whether the Council should consider correspondence addressed to it if it is anonymised.*

(b) **Yng Cofnod - 266/2018-19(b)** - Cafodd y cyfarfod ei ohirio. Penderfynwyd trefnu dyddiad newydd cyn gynted ag y bo modd. / ***Minute 266/2018-19(b) refers*** – *The meeting had been postponed. Resolved that a new date be arranged as soon as possible.*

(c) **Yng Cofnod - 266/2018-19(c)** - Mae'r Clerc wedi gofyn am eglurhad ar y mater hwn gan Un Llais Cymru. Penderfynwyd nodi / ***Minute 266/2018-19(c) refers*** – *The Clerk has asked for clarification on this matter from One Voice Wales. Resolved to note.*

(d) **Yng Cofnod - 269/2018-19** - Y cyngor gan Un Llais Cymru yw y gellir defnyddio'r Pŵer Lles er budd unigolyn unigol ac nid yw hynny'n wir gydag Adran 137. Penderfynwyd nodi. / ***Minute 269/2018-19refers*** – *The advice from One Voice Wales is that the Power of Well-being may be used for the benefit of a single individual which is not the case with Section 137. Resolved to note.*

(e) **Yng Cofnod - 274/2018-19** - Ni all TBM darparu gwasanaeth i'r Cyngor bellach oherwydd eu llwyth gwaith cynyddol. Mae'r Clerc eisoes wedi diolch iddynt am eu gwaith, ond mae'n dal i aros am ddychwelyd asedau'r Cyngor o'u gweithdy. Pwysleisiodd y Clerc fod angen ymhel â ofynion cynnal a chadw, yn enwedig y sedd yn Sgwâr Hibbard, Mynyddcerrig a'r slat sydd ar goll ar y sedd yn Llanddarog. Awgrymodd yr Aelodau y gallai fod contractwyr lleol a allai gynorthwyo. Penderfynwyd bod y Clerc yn edrych i mewn i'r mater ac yn cael eglurhad ar y sefyllfa o ran yswiriant. / **Minute 274/2018-19refers** – *TBM can no longer provide a service to the Council due to their increasing workload. The Clerk has already thanked them for their work, but is still awaiting return of Council assets from their workshop. The Clerk emphasised that maintenance requirements need attending to, particularly the seat at Sgwar Hibbard, Mynyddcerrig and the missing slat on the seat in Llanddarog. Members suggested that there may be local contractors who could assist. Resolved that the Clerk look into the matter and attain clarity on the position in terms of insurance cover.*

(f) **Yng Cofnod - 275/2018-19** - Adroddodd y Cyng. J Williams ei fod wedi gorfod ailymweld â'i ymateb arfaethedig i'r ymgynghoriad gan fod ei ymateb gwreiddiol yn seiliedig ar ymgynghoriad blaenorol sydd bellach wedi dod i ben. Fodd bynnag, roedd pwyslais cyffredinol ei sylwadau yn dal i gael eu hystyried yn berthnasol o ran pwysigrwydd annibyniaeth leol wrth gadw at safonau cenedlaethol. Penderfynwyd diolch i'r Cyng Williams am ei ddiweddariad ac os yw ef yn dal yn ystyried yr ymgynghoriad yn berthnasol, mae dal ganddo gymeradwyaeth y Cyngor i ddod ag ymateb at ei gilydd ar gyfer cyflwyno. / **Minute 275/2018-19refers** – *Cllr J Williams reported that he has had to revisit his proposed consultation response as his original response was based around a previous consultation which has now closed. The general thrust of his comments were however still considered pertinent in terms of the importance of local autonomy whilst adhering to national standards. Resolved to thank Cllr Williams for his update and should he still deem the consultation relevant he maintains the approval of the Council to pull together a response for submitting.*

(g) **Yng Cofnod - 276/2018-19** - Cwestiynodd yr Aelodau yr angen am gonaect prosesu data - yn enwedig gyda chwmni argraffu'r Cyngor. Dywedodd y Clerc fod y Cyngor wedi derbyn cyngor gan y Comisiynydd Gwybodaeth y dylai fod contract ar waith rhwng rheolwr data a phrosesydd data. Cyfeiriwyd hefyd at broseswyr data eraill y Cyngor, gan gynnwys y cwmni cyflogres. Penderfynwyd ni ddylai unrhyw gonaectau cael ei llunio gyda phrosesydd (wyr) data'r Cyngor gan fod yr Aelodau o'r farn y byddai gan y cwmnïau hyn eu cyfrifoldebau a'u safonau eu hunain i'w bodloni./ **Minute 276/2018-19refers** – *Members questioned the need for a data processing contract – notably with the Council's printing company. The Clerk advised that the Council had received advice from the Information Commissioner that there should be a contract in place between a data controller and data processor. Reference was also made to the Council's other data processors, including the payroll company. Resolved that there be no contracts formulated with the Council's data processor(s) as Members were of the opinion that these companies would have their own responsibilities and standards to meet.*

The Council has an established special projects programme which would enable delivery of the shelter should the Council decide to prioritise it. Resolved that the Council confirm its priority from its special projects programme at its April 2019 meeting.*

(b) Gweithredoedd yn sgil ohebiaeth / *Actions resulting from correspondence:*

1 E-bost gan breswlydd Porthyrhyd - Derbyniwyd yr e-bost ar ôl i'r agenda fynd allan ond roedd yr Aelodau'n hapus i'w ystyried gan nad oedd ganddo oblygiadau ariannol neu bolisi sylweddol i'r Cyngor hwn. Roedd yr ohebydd yn deall bod Cyngor Sir Caerfyrddin yn bwriadu cyflwyno taliadau parcio mewn lleoliadau ar draws Sir Gaerfyrddin sydd am ddim ar hyn o bryd, gan gynnwys yng Nghoedwigoedd y Tymbl yng Nghwm Gwendraeth. Penderfynwyd bod y Clerc yn gwneud sylwadau ar ran y Cyngor trwy Gynghorydd Sir etholedig yr ardal hon yn amlinellu pryderon y Cyngor hwn am yr effaith bosibl ar drigolion o ran lles os effeithir ar hygyrchedd yr ardaloedd hyn. Mae yna hefyd gwestiynau o ran cost-fudd. Roedd pryder hefyd nad oedd y cynigion hyn wedi ymddangos ar dudalen we "ymgynghoriadau presennol" y Cyngor Sir, er y cyfeiriwyd at fodolaeth y wefan "hysbysiadau cyhoeddus". / ***E mail from Porthyrhyd resident*** – *The e mail was received after the agenda had gone out but Members were happy to consider it as it had no substantive financial or policy implications for this Council. The correspondent understood that Carmarthenshire County Council was proposing to introduce parking payments at locations across Carmarthenshire that are currently free, including at Tumble Woodlands in the Gwendraeth Valley. Resolved that the Clerk make representations on behalf of the Council via this area's elected County Councillor outlining this Council's concerns on the potential impact on residents in terms of well-being if the accessibility of these areas is affected. There are also questions in terms of cost-benefit. There was also concern that these proposals had not appeared on the "current consultations" webpage of the County Council, albeit reference was made to the existence of the "public notices" webpage.*

2 Sioe Llanddarog - Derbyniwyd y llythyr ar ôl i'r agenda fynd allan ond roedd yr Aelodau'n hapus i'w ystyried gan fod problem o ran amserlen. Eleni, hoffai'r sioe gael cadarnhad o'r nawdd yn gynnwys oherwydd anghenion argraffu. Nodwyd bod cadarnhad o'r nawdd gan y Cyngor fel arfer yn ei gyfarfod mis Mai, ond roedd yr Aelodau'n hapus i benderfynu cadarnhau'r nawdd o £200.00 ar gyfer sioe 2019 oherwydd yr anghenion argraffu. / ***Llanddarog Show*** – *The letter was received after the agenda had gone out but Members were happy to consider it as there was a timescale issue. This year the show would like confirmation of sponsorship early due to printing needs. It was noted that confirmation of sponsorship by the Council is normally at its May meeting, however Members were happy to resolve to confirm the sponsorship of £200.00 for the 2019 show given the printing needs.*

Ni chafwyd unrhyw ymateb i'r hysbysiad cyfethol. Dywedodd y Clerc fod angen i'r Cyngor ddangos ei fod yn ceisio llenwi'r swydd wag. Er y rhoddwyd ystyriaeth briodol i gynnig (a eiliwyd) i beidio ag ail-hysbysebu'r sedd a'i gadael yn wag tan ddiwedd tymor y Cyngor (yn amodol ar ddim mwy o seddau'n dod yn wag), penderynwyd yn y pen draw ail-hysbysebu hysbysiad o gyfethol ar-lein ac yn yr hysbysfyrddau dan y ddealltwriaeth bod rhwymedigaeth ar y Cyngor i geisio llenwi'r sedd cyn gynted ag y bo'n ymarferol bosibl. Bydd yr hysbysiad felly'n datgan bod y Cyngor yn awyddus i lenwi'r sedd cyn gynted â phosibl ac na fydd yn cynnwys dyddiad cau. Bydd y Cyngor yn ystyried unrhyw ddiddordeb a dderbynnir maes o law. / *There had been no response to the co-option notice. The Clerk advised that the Council needs to show it is trying to fill the vacancy. Whilst due consideration was given to a motion (which was seconded) to not re-advertise the seat and leave it vacant until the end of the Council term (subject to no more seats becoming vacant), it was eventually resolved to re-advertise the notice of co-option online and in the notice boards given that it was understood that there was an obligation on the Council to attempt to fill the seat as soon as practicably possible. The notice will therefore state that the Council is keen to fill the seat as soon as possible and will not include a closing date. The Council will consider any interest received in due course.*
