Opportunity for the public to address the Council on agenda items (This agenda item stated that the Council will be receiving a representative of Mynyddcerrig Welfare Committee in this regard).

Diolchodd y cynrychiolwyr o bwyllgor Llesiant Mynyddcerrig i'r Cyngor am ei grant refeniw sefydlog o £500. Fe wnaethent roi drosolwg o'r math eang o weithgareddau a chyfleusterau maent yn ymgymryd â hwy. Fe wnaethent roi pwyslais ar y pwysigrwydd o weithio mewn partneriaeth ar lefel gymunedol. Ar ôl cael ei ddiolch am ei bresenoldeb, gadawodd y cynrychiolwyr y cyfarfod am 7.40pm, heb ddychwelyd. Fe'i cynghorwyd nad oes angen i bwyllgor Llesiant Mynyddcerrig fynychu cyfarfod o'r Cyngor eto am y tymor hwn os byddent yn derbyn taliadau grant refeniw sefydlog pellach. / *The representatives from Mynyddcerrig Welfare Committee thanked the Council for its standing revenue grant of £500. They provided an overview of the wide range of activities and facilities that the Committee undertakes. They emphasised the importance of partnership working at community level. Upon being thanked for their attendance, the representatives left the meeting at 7.40pm, not to return. They were advised that Mynyddcerrig Welfare Committee does not need to attend a Council meeting again for this term should it receive further standing revenue grant payments.*

Policing and Road Safety Matters - including Porthyrhyd traffic speed survey results.
Roedd yr Aelodau wedi derbyn y data arolwg cyflymder ar gyfer Porthyrhyd cyn y cyfarfod. Nodwyd hefyd fod yr arwydd ildio yn Llanddarog dal heb gael ei ddod yn ôl. Penderfynwyd gofyn am arolwg pellach i gael ei gynnal ar y ffordd mewn i Borthyrhyd o Drefach ar leoliad yr arwyddion 30mya. Hefyd, fe fydd y Clerc yn cysylltu â'r Cyngor Sir ynglŷn â'r arwydd ildio yn Llanddarog. /

Members had received the speed survey data for Porthyrhyd in advance of the meeting. It was also noted that the missing give way sign in Llanddarog has yet to be replaced. It was resolved to request that a further survey be undertaken on the approach to Porthyrhyd from Drefach located at the 30mph signs. Also, the Clerk will contact the County Council in relation to the give way sign in Llanddarog.

Fe rhoddodd diweddariad ar y cofeb ryfel ym Mhorthyrhyd. Penderfynwyd diolch i'r Cadeirydd am ei adroddiad. / *The Chairman welcomed everyone to the meeting. He had been unable to attend Llanddarog Show but had attended the recent Quarry liaison meeting. He provided an update on the war memorial in Porthyrhyd. Resolved to thank the Chairman for his report.*

Ar ôl cynnig gan y Cyng J Williams ac eilio gan Cyng H Jones; pendderfynwyd cadarnhau a llofnodi'r cofnodion (dan law'r cadeirydd llywyddol), yn amodol ar nodi y dylai cofnod 68/2019-20 wedi cyfeirio at ddatblygu lliw gwybodaeth ddwy ffordd fel y gall y Cyngor gynorthwyo gydag unrhyw bryderon perthnasol neu ddysgu am unrhyw ddigwyddiadau ac ati. Bydd yr eglurhad hwn yn cael ei anfon ymlaen at y llywodraethwr cymunedol mewn hyn o beth. / *Following a proposal by Cllr J Williams and seconding by Cllr H Jones, it was resolved to confirm and sign the minutes (under the hand of the presiding chairman), subject to it being noted that minute 68/2019-20 should also refer to developing a two way flow of information so that the Council can assist with any relevant concerns or learn of any events etc. This clarification will be forwarded to the community governor in this regard.*

(a) **Yng Cofnod 54/2019-20** - Ystyriwyd ymateb ysgrifenedig wrth Is-adran Gwasanaethau Amgylcheddol a Gwastraff Cyngor Sir Caerfyrddin. Roedd yr Aelodau yn teimlo'n rhwystredig, yn enwedig o ran y diffyg ymgynghori a waned cyn dod i mewn a'r polisi newydd. Roedd yr Aelodau'n dymuno mynegi y gall anghenion ardaloedd gwledig y Sir fod yn wahanol i anghenion ardaloedd trefol. Penderfynwyd bod y Clerc yn ysgrifennu at y Cyng. Hazel Evans, yr Aelod o'r Bwrdd Gweithredol dros yr Amgylchedd - gyda chopi i'r Prif Weithredwr a'r Cynghorydd Sir A Davies - i amlinellu'r pryderon hyn. / **Minute 54/2019-20 refers** - *A written reply from Carmarthenshire County Council's Environmental & Waste Services Division was considered. There was frustration amongst Members, particularly in terms of the lack of consultation*

undertaken before bringing in the new policy. Members wished to express that the needs of the County's rural areas can differ from that of its urban areas. Resolved that the Clerk write to the Cllr Hazel Evans, Executive Board Member for Environment – with a copy to the Chief Executive and County Cllr A Davies - to outline these concerns.

(b) Yng Cofnod 56/2019-20 - Penderfynwyd dilyn i fynny ar y cais am rhoi pris am ddarparu arwyddion cyflymder traffig sy'n fflachio ym Mhorthyrhyd. / **Minute 56/2019-20 refers** – *It was resolved to follow up on the request for providing a price for the provision of flashing traffic speed signs in Porthyrhyd.*

(c) Yng Cofnod 64/2019-20 - Roedd yr Aelodau wedi cael eu gwerthuso'n llawn ar y sefyllfa o ran caniatâd cynllunio a fe'i ystyriwyd nad oedd angen caniatâd. Cadarnhaodd y Cyng. J Williams fod y lloches wedi'i gosod a bod y gwaith ategol wedi'i gwblhau. Codwyd ymholiad ynghylch pwy sy'n berchen ar yr hysbysfwrddau yn lloches Llanddarog ger y Butchers a ger Neuadd / Clwb Mynyddcerrig. Dywedodd yr Aelodau fod y Cyngor yn berchen ar yr un yn Llanddarog ond nad yw'r un ym Mynyddcerrig yn eiddo i'r Cyngor. Penderfynwyd awdurdodi talu'r symiau canlynol - BC Energy Solutions LTD £5,148 a KG Fittings (Mr Gibbard) £311.84. Bydd yr hysbysfwrdd yn lloches Llanddarog ger y Butchers yn cael ei gynnwys o fewn y gwerth lloches bws ar y gofrestr asedau. Penderfynwyd ymhellach i osod nodyn o ddiolch i'r is-bwyllgor ar y cofnodion am oruchwylio cyflwyno'r prosiect hwn. / **Minute 64/2019-20 refers** – *Members had been kept fully appraised on the position in terms of planning permission and it had been considered that permission was not required. Cllr J Williams confirmed that the shelter had been installed and that ancillary work had been completed. A query was raised as to who owns the notice boards in the Llanddarog shelter adjacent to the Butchers and adjacent to Mynyddcerrig Hall / Club. Members advised that the Council owns the one in Llanddarog but that the one in Mynyddcerrig is not in its ownership. Resolved to authorise payment of the following sums – BC Energy Solutions LTD £5,148 and KG Fittings (Mr Gibbard) £311.84. The notice board in the Llanddarog shelter adjacent to the Butchers will be included within the bus shelter value on the asset register. Further resolved to place a note of gratification to the sub-committee onto the minutes for overseeing the delivery of this project.*

Resolved to note.*

99/2019-20 - Prosiect Goleuadau Cymunedol Cyngor Sir Gâr / Carmarthenshire County Council's Community Lighting Project.

Roedd yr Aelodau wedi derbyn y gwaith papur cyn y cyfarfod. Mae'r Cyngor Sir wedi llunio cynnig prosiect ar gyfer Cyngorau Tref a Chymuned ei ystyried ar gyfer newid ei goleuadau cymunedol i unedau LED. Fe fydd angen i'r Cyngor Cymuned wneud addaliad benthyciad blynyddol o £747.13 y flwyddyn dros cyfnod o wyth mlynedd. Yn seiliedig ar gostau ynni a amcangyfrifwyd gan Lywodraeth Cymru ar gyfer y cyfnod wyth mlynedd, cost ynni y Cyngor Cymuned a amcangyfrifwyd gyda'r goleuadau sodiwm pwysedd isel fyddai £1,202.08 y flwyddyn ar gyfartaledd, ond disgwylir y byddai hyn yn gostwng i £337.43 y flwyddyn gyda'r unedau LED. Fe benderfynwyd cadarnhau fod Cyngor Cymuned Llanddarog am fod yn rhan o'r prosiect. Fe fydd y Cyngor beth bynnag yn mynegi ei phryderon ynglŷn â golau rhif uned 301-2374 (ger Disgwylfa Porthyrhyd) gan ei fod wedi cuddio gan goedwig ar hyn o bryd. / *Members had received the paperwork in advance of the meeting. The County Council has put together a project proposal for Town and Community Councils to consider changing their community lights to LED units. The Community Council will be required to make an annual loan repayment of £747.13 a year over an eight year period. Based on estimated energy costs advised by Welsh Government for the eight year period, the Community Council's predicted energy cost with the current low pressure sodium lighting would average £1,202.08 a year, but this is estimated to drop to £337.43 a year with the LED units. It was resolved to confirm that Llanddarog Community Council wishes to participate in the project. The Council will however outline its concerns with regards light unit number 301-2374 (adj. Disgwylfa Porthyrhyd) as it is obscured behind trees at the present time.*

100/2019-20 Ystyried wardio'r Cyngor / Consideration of warding the Council.

Roedd yr aelodau wedi derbyn gwaith papur cyn y cyfarfod. Cafwyd trafodaeth ar rinweddau posib wardio'r Cyngor i Borthyrhyd, Llanddarog a Mynyddcerrig. Cynigiodd y Cyng J Williams fod y Cyngor yn sefydlu wardiau, ond ni eiliwyd - gyda'r consensws o blaid gadael y Cyngor fel y mae. Penderfynwyd bod y Cyngor yn parhau i fod heb wardiau. / *Members had received paperwork in advance of the meeting. There was discussion on the possible merits of warding the Council into Porthyrhyd, Llanddarog and Mynyddcerrig. Cllr J Williams moved that the Council establish wards, but this was not seconded - with the consensus being to leave the Council as it is. It was resolved that the Council is to remain un-warded.*

Roedd yr Aelodau yn parhau i bryderi ynghylch cyflwr blychau ffôn BT yn yr ardal. Fe wnaeth yr Aelodau dderbyn ymatebion y Cyngor i'r ymgynghoriad blaenorol ar y bwriad i gael gwared ar y blychau ym mis Tachwedd 2016 cyn y cyfarfod. Deallir ei bod yn annhebygol y bydd BT yn buddsoddi yn y blychau gan fod ymgynghoriad pellach ar y bwriad i gael gwared ar y blychau. Roedd yr Aelodau'n barod i archwilio'r posibilrwydd o fanteision cael gwared ar flychau (yn benodol mewn perthynas â blwch Is-Y-Llan, Llanddarog). Fodd bynnag, bydd safbwynt y Cyngor yn cael ei ystyried yn ffurfiol maes o law. Penderfynwyd bod y Cyngor yn ceisio cael rhagor o wybodaeth am yr ymgynghoriad arfaethedig gan BT cyn ystyried ymhellach. / *Members continued to be concerned in relation to the condition of BT phone boxes in the area. Members*

had been provided with the Council's responses to the previous consultation on proposed removal of the boxes in November 2016 in advance of the meeting. It is understood that it is unlikely that BT will invest in the boxes as there is a further consultation on proposed removal due to be undertaken. Members were open to exploring the advantages of removing boxes (particularly in respect of Is-Y-Llan, Llanddarog). However, the Council's policy position on this matter will be formally considered in due course. Resolved that that Council seek further information on the proposed consultation by BT before considering further.

Resolved to ask County Cllr A Davies to raise this within the County Council.*
