Mynychodd aelod o'r gymuned y cyfarfod i awgrymu syniadau amrywiol i wella diddordeb pentref porthyrhyd (carreg filltir, bwrdd hanes, ac ati). Codwyd pryderon ynghylch gallu'r system garthffosydd gyfredol ar y cyd â'r safle datblygu arfaethedig gyferbyn â neuadd bentref Llanddarog. Esboniodd y Cynghorydd R Newell nad oedd unrhyw wybodaeth ar gael ond y byddai'r mater yn cael ei ymchwilio. Diolchodd yr aelod y Clerc Cynorthwyol dros dro am ei waith gwerthfawr fel y Clerc dros yr ychydig flynyddoedd diwethaf a rhoddodd groeso i'r clerch newydd. Diolchwyd yr aelod cyhoeddus am ei mewnbwn a gadawodd y cyfarfod am 7.43pm - i beidio â dychwelyd. Penderfynwyd i'r clerch ddod o hyd i wybodaeth o Dŵr Cymru.

A member of the community attended the meeting to suggest various ideas to enhance the interest of the village of Porthyrhyd (milestone, history board, etc). The member illustrated the positive impact of the Cwm Gwendraeth Men's Shed within the vicinity. Concerns were raised regarding the capability of the current sewer system in conjunction with the proposed development site opposite Llanddarog village hall. Cllr R Newell explained that no information was available but the matter would be

investigated. She expressed a thank you to the Temporary Assistant Clerk for his valuable work as the Clerk over the past few years and welcomed the new Clerk. The public member was thanked for her input and left the meeting at 7.43pm – not to return. Resolved for clerk to source information from Welsh Water.

Cymuned Llanddarog a dylid eu cwblhau mewn 3 mis. Mae'r polisi'n nodi bod gan drigolion lleol y dewis cyntaf ar yr eiddo a adnewyddwyd ac os nad oes galw, estynnir y cynnig i'r ward gyfagos. Penderfynwyd nodi.

In response to this matter, County Councillor A Davies returned after further discussions with the County Council to clarify that there are in excess of 2000 empty homes in Carmarthenshire and the policy is to either find tenants for the properties or to sell. If the properties are independently owned, grant funding is available but a clause stipulates that the property could not be sold for a minimum of 5 years and must be available to rent through the council. Three properties are currently being renovated within Llanddarog Community Council boundary and should be completed in 3 months. Policy stipulates that local residents have first choice on the renovated properties and if there is no demand, the offer is extended to the adjacent ward.

Following a proposal by Cllr R Jones and seconding by Cllr J Williams it was resolved to accept the financial report, along with the bank reconciliation as presented. Further resolved to amend the future layout of the budget report so that income and expenditure are individually listed under the relevant budget headings (i.e. essentially duplicate the cashbook for Members viewing). It was also decided to name the parties involved under the financial assistance heading and to omit Section 137 from the expenditure list in future budgets.

Nododd yr aelodau fod y swm hwn wedi'i gynnwys yn y gyllideb ddrafft ar gyfer 2020/2021 ac o ganlyniad byddai'r gronfa gyffredinol yn dechrau cael ei hail-lenwi o Ebrill 1 2020 ymlaen. Roedd pob un yn cytuno, wrth osod y gyllideb ar gyfer 2020/21, y dylai unrhyw ddefnydd o falansau cyffredinol fod yn fach iawn / atodol gan y dylai'r pwyslais dros y flwyddyn neu ddwy i ddod fod ar ailgyflenwi. Yn dilyn cynnig gan y Cynghorydd R Jones ac eilio gan y Cyng J Williams penderfynwyd derbyn yr adroddiad fel y'i cyflwynwyd. Penderfynwyd ymhellach i lunio polisi cronfeydd wrth gefn sy'n darparu targed ar gyfer faint o gronfeydd wrth gefn cyffredinol y bydd y Cyngor yn ceisio eu dal. Penderfynwyd ymhellach bod y Cyngor yn archwilio'r ddarpariaeth o fenthyca fel a lle bo hynny'n briodol fel rhan o'i drafodaethau yn y dyfodol.

Each Member had received a copy of the report in advance of the meeting. It should be noted that due consideration was given to balances / reserves. It was noted that there was a projected balance of £8,109.20 going forward (all non-earmarked – general fund). This allowed Members to factor in impact of project spend during the year in addition to the position on the revenue budget. It also allowed them to review the extent of reserves that the Council holds. Whilst the Council risk assesses its reserves, has had Strategies (notably back in 2017) and does establish earmarked reserves (eg to deliver specific projects), it does not have a specific policy target on needed to be held in the general fund. Members were advised that guidance states that general / free reserves should typically be in the range of 3 to 12 months of expenditure (typically net revenue expenditure). From research online, it appears that other Councils seem to aim for 50% of the precept and that smaller Councils are generally accepted the need to be closer to 12 months than larger ones. The issue is that Councils cannot be seen to unduly stockpile general reserves for no reason either, so a suitable balance needs to be achieved in this regard. Members noted that the Council's general / free reserves have been notably depleted during the year, primarily to assist in delivering the new shelter as opposed to revenue budget issues. Members noted that the projected balance sum of £8,109.20 is 45% of this year's precept (under 50%) and represents under 5 and a half months net revenue expenditure which all agreed was a little on the low side. As a result of a proactive approach to risk management, the Council resolved in September 2019 to earmark a sum of £1750 from the 20/21 precept to go into the free/general reserves. Members noted that this sum is included in the draft budget for 2020/2021 and as a result the general fund would start to be replenished from April 1 2020 onwards. All were in agreement that in setting the budget for 2020/21, any utilisation of general balances should be very minimal / incidental as the emphasis over the coming year or two should be on replenishing. Following a proposal by Cllr R Jones and seconding by Cllr J Williams it was resolved to accept the report as presented. Further resolved to draw up a reserves policy that provides a target for the amount of general reserves the Council will seek to hold. Further resolved that the Council explores the provision of borrowing as and where appropriate as part of its future deliberations.
