Mr Terry Jones (Community Council Representative of School Governors) thanked the members for his invitation to give an appraisal on Llanddarog Primary School's performance over the past 12 months and to give an update on events that would engage the community. It was reported that a school inspection was performed earlier in the academic year and that due to unforeseen circumstances the school had slipped from a yellow to an amber section but that matters were in hand and plans were in place to regain the yellow status.
