Adroddodd y Cynghorydd Sir A Davies, oherwydd pandemig Covid-19, bod oedi mewn ymateb i faterion cyhoeddus gan fod llawer o weithwyr y cyngor yn gweithio o gartref. Er mwyn hwyluso galw'r cyhoedd o bwysau sy'n ymwneud â'r pandemig, roedd Parc Y Scarlets a Chanolfannau Hamdden Caerfyrddin a Llanelli yn cael eu haddasu i ddarparu ar gyfer 700 o welyau ychwanegol i gynorthwyo'r GIG yn Sir Gaerfyrddin. Os oedd angen cymorth ar y gymuned, roedd gan y Cynghorydd Davies nifer o wirfoddolwyr yn barod i gynorthwyo'r preswylwyr o ran dod o hyd i fwyd neu gyflenwadau meddygol neu ddim ond sgwrs gyfeillgar ar y ffon. Holodd y Cynghorydd R Jones am agor Gerddi Botaneg Cenedlaethol Cymru yn ystod y pandemig oherwydd diffyg llwybrau troed cyhoeddus yn yr ardal a phryderon am ddiogelwch y cyhoedd wrth i fwy o bobl gerdded ar y ffyrdd. Dangosodd y Cynghorydd H Jones bryder yn ymwneud â'r mater hwn gan y byddai agor y gerddi yn denu nifer enfawr o bobl ac er bod yr atyniad dros 500 erw, byddai canllawiau'r llywodraeth yn atal yr ailagor. Roedd y Cynghorydd H Jones hefyd wedi derbyn

ymchwiliad cyhoeddus ynglŷn â gohirio treth y cyngor yn ystod y pandemig. Cadarnhawyd gan y Cyngorydd R Newell ei bod yn bosibl gohirio'r taliad am ddau fis, felly byddai taliadau'n cychwyn ym mis Mehefin ac yn parhau tan fis Mawrth. **Penderfynwyd** diolch i'r Cyngorydd Sir A Davies am ei hadroddiad.

County Cllr A Davies reported that due to the Covid-19 pandemic, there was a delay in response to public matters as many council employees were working from home. To facilitate public demand from pressures relating to the pandemic, Parc Y Scarlets and both Carmarthen and Llanelli Leisure Centres were being modified to accommodate an extra 700 beds to assist the NHS in Carmarthenshire. If assistance was required by the community, Cllr Davies had a number of volunteers willing to aid the residents with regards to sourcing food or medical supplies or just a friendly chat on the telephone.

*Cllr R Jones enquired about opening the National Botanic Gardens of Wales during the pandemic due to the lack of public footpaths in the area and concerns for public safety as more people were walking on the roads. Cllr H Jones showed concern relating to this matter as opening the gardens could attract a large number of people and although the attraction was over 500 acres, government guidelines would prevent the re-opening. Cllr H Jones had also received a public enquiry regarding the deferral of council tax during the pandemic. It was confirmed by Cllr R Newell that it was possible to defer the payment for two months, therefore payments would begin in June and carry on until March. It was **resolved** to thank County Cllr A Davies for her report.*
