### **50/2021-2022** Policing and Road Safety Matters

Cllr J Williams O.B.E. confirmed that a site meeting had been arranged on 18/06/2021 at 14.00 regarding the DFS (Driver Feedback Sign) at Lan Lucis Bridge. Cllr J Williams O.B.E. and Cllr R Jones to attend.

### **51/2021-2022** County Council matters - County Cllr A Davies.

County Cllr A Davies reported that a number of complaints had been received regarding 2 large sheds which had been built in Is y Llan to facilitate a small business. This is now being investigated.

County Cllr A Davies informed Council members that Llanddarog and Porthyrhyd Halls have reopened and that risk assessments and signage were in place to comply with Covid-19 regulations.

Carmarthenshire County Council have recently donated £48K to the food banks within the County. £43K has come from renewable energy income from Solar Panels and the remaining £5K from proceeds of crime via trading standards.

The cluster of 18 Covid cases in Pontyberem have been contained to a family and their associates therefore no mass testing will take place at the moment. Most of the cases are younger adults who have only had one or no vaccine and the situation is being monitored very closely.

County Cllr A Davies also reported that Llanarthne Village Hall are launching a Crowdfunding campaign on 09/06/2021 as part of the Calor Gas Rural Community Fund to raise the final £22k required to complete the extension which will see outside toilets for the park and an extended hall with more capacity for events and classes. Llanarthne Village Hall are £22k short of the final amount required and this is partly due to increased material costs as a result of the Covid-19 pandemic. The cost of the extension went up by £11k + VAT. Community members can access the Calor Gas Fundraiser page, click on the "like" button which will give the hall 1 point. If members

can donate £1.00, the crowdfunding will give the hall 10 points. The project with the most points at the end of the month will have the £5,000 prize from Calor Gas Rural Community Fund. Please share this as much as you can in order to maximize our chances.

The Chair also informed Council members that the telephone kiosk had now been removed from Is y Llan.

### 60/2021-2022 Safer Communities Walkway

The Clerk informed Council members that he had contacted Carmarthenshire County Council with regards to the Safer Communities Walkway Programme for a footpath/cycle path from the Mansel Arms to Porthyrhyd and a reply had been received from Mr Thomas Evans (Transport Planner – Transport and Highways Division) regarding the issue. Please see reply -

"From what you outlined regarding the provision of walking/cycling facilities between Drefach/Porthyrhyd, I'm afraid this scheme on its own would not fit the criteria for a full Safe Routes in Communities bid (SRiC). The focus on any SRiC bid has to be enhanced active travel provision leading to and from the school (with the school anchoring and supporting the bid).

Please note that we have included the requested link (active travel route between Drefach and Porthyrhyd) on our Active Travel Network Map that we will be submitting to Welsh Government in December. If there are any other additions you can think of, please add them using the following link:

The Clerk also informed Council members that he had spoken with Mrs Lauren McNee (Support Officer – Sustrans) regarding the same issue and that a senior officer would be in contact in the near future. **Resolved** to note and place on the July agenda.

Cllr J Williams O.B.E. asked why a footpath/cycle path had recently been constructed from Blaenau – Caebryn and Llangennech – Dafen as no schools were within the vicinity. County Cllr A Davies replied that it may be due to the population in the area, but she would enquire with the relevant department. **Resolved** to note and receive update in the July meeting on 14/07/2021.

Cllr J Youens enquired as to the location of the bench removed in error from Mynyddcerrig in March 2021. The Clerk updated Council members that the bench was in his shed and that the contractor was waiting for him to collect composite timber from the supplier. Resolved for the Clerk to collect the material ASAP.

Cllr M Rees reported on the condition of the road surface on the slipway to Llanddarog and Porthyrhyd. **Resolved** for the Clerk to inform Trunk Road Services.

The Clerk informed council members that he had been approached by other community councils regarding the Zoom online platform for meetings. The Clerk stated that there was a possibility for Llanddarog Community Council to allow other parties to utilise the facility and charge a small donation for the privilege. Council members discussed the proposal and if the Clerk was willing to arrange and facilitate the meetings for other parties at a donation cost of £20.00 per meeting, there was no objection. Proposed by Cllr J Williams O.B.E and seconded by Cllr H Jones. All agreed. **Resolved** to note.
