70/2025-2026 County Council matters - County Cllr S Hughes.

County Cllr S Hughes read the following report –

"I attended the Corporate Performance & Resources Scrutiny Committee in June.

I am still waiting for a date from the National Botanical Garden of Wales for a possible site visit to discuss commemorating 25 years of the Gardens.

The Welsh Government is still undertaking studies and appraising options to improve the junction arrangements at Nantycaws. Studies have reached Stage 2, and a preferred option to improve conditions is due to progress to Stage 3, where key stakeholders will be invited to consult on the preferred option later this year,

I am continuing to help and support local people with their queries and concerns, most of which are of a confidential nature".

71/2025-2026 Chairman's Report.

The Chair announced that he attended the official opening of the new Llanddarog Village Hall on 13/06/2025 with Cllr R McFarlane (Vice-Chair) and that an excellent evening was enjoyed by all.

The Chair announced that he attended Llanddarog & District Show on 28/06/2025 and congratulated the committee members on all their hard work and commitment for hosting a successful event.

The Chair stated that several volunteers came together on 05/07/2025 to complete the concrete slab around the memorial stone in Porthyrhyd. The Chair thanked everyone involved for all their hard work and commitment to completing the slab.

<u>72/2025-2026</u> Confirmation and signing of the Minutes of the Council Meeting 11/06/2025.

It was **resolved** to confirm the minutes for the General Meeting and the monthly meeting on 11/06/2025. Proposed by Cllr R Owen and seconded by County Cllr S Hughes.

73/2025-2026 Matters arising from the above minutes.

The Clerk informed council members that all matters to **resolve** had been actioned and if correspondence had been received, a copy of the Email had been sent to each member for information.

The Clerk reported that no update had been received from Carmarthenshire County Council regarding the refuse bin in Mynyddcerrig.

The following response was received on 25/06/2025 regarding the following question asked by Cllr R Jones in the June 2025 meeting – **Minute 55/2025-2026.**

"Cllr R Jones asked County Cllr S Hughes "why were they proposing to change the speed limit to 50mph when the speed limit had previously been changed to 50mph without consultation and who authorised the change?"

Response: I would inform you that unfortunately the signs were originally erected in error, this Order will now ensure that the 50mph speed limit is legally *enforceable*.

The Clerk reported that he had sent an email Mr Mike Jacob (Traffic and Road Safety Manager) regarding the C2061 from Porthyrhyd to Foelgastell but no update had been received.

The following email was received on 01/07/2025 from Carmarthenshire County Council and forwarded to all council members.

"Cllr. Hefin Jones has recently changed governor category – he now serves as LA Governor.

John Williams' resignation leaves a vacancy in the role of Additional Community Governor - this post can only be filled via a nomination from the Community Council. The nominee can be one of your members, or it can be someone from the wider community, as long as they are nominated by the CC. Without a nomination, the post will remain vacant".

The Clerk reminded council members that this topic was discussed in the May 2025 meeting – **Minute 12/2025-2026** and the following was minuted -

"It was confirmed that County Cllr H Jones was to remain as representative of Llanddarog Community Council on Llanddarog School's Governing Body for the foreseeable future but if there is a change in his role, Cllr R McFarlane will replace him as representative if acceptable with the school. Proposed by Cllr J Williams O.B.E and seconded by Cllr R Owen".

The Clerk stated that as a decision it had already been passed by council members and that he would inform Carmarthenshire County Council that Cllr R McFarlane had been nominated as an Additional Community Governor. **Resolved** to note.

The following response was received on 23/06/2025 regarding the following question asked by Cllr R Owen in the June 2025 meeting – **Minute 62/2025-2026**.

"Cllr R Owen reported that the ditches along the U2269 road from Mynyddcerrig to Pontyberem required clearing as the road surface is waterlogged during heavy rainfall"

Response: The Highway Inspector has looked at the area in question and has advised that some patching works will be needed. I am unable to give a date as to when this will be done as we are currently carrying out prioritised patching in readiness for our Surface Dressing program. This will be programmed and prioritised once the Surface dressing section has been completed.

78/2025-2026 To receive the Internal Financial Examiners report.

Each member had been provided with a written report prior to the meeting. A full verbal report was provided by the Clerk.

During a meeting between Mr Evans, Clerk, and myself on the 6th July 2025, I undertook a review of the following:

- 1) An examination of the bank statements for the latest period under review (April 2025 to June 2025). I have initialled the April and May bank statements. The June statement has been viewed, confirmed and signed.
- 2) The accuracy of the ongoing account that will be presented to Council at the meeting on the 9th July 2025.
- 3) That payments made by the Council are supported by invoices or by signed receipts. There are currently two receipts which haven't been received in respect of annual donations. These should be forthcoming during the next financial period. I have undertaken a review of invoices, cheque stubs (no cheques issued during this period), and the paying-in book (no manual deposits have been made during this period) for all transactions covering the period 1st April 2025 to 30th June 2025.
- 4) That VAT has been correctly accounted for and can been reclaimed when appropriate.
- 5) That income has been recorded and banked (where necessary) correctly.
- 6) Payments to staff and members have been examined and the figures, including pension payments and tax due to HMRC, agreed.
- 7) Progress against the 2025/2026 annual budget has been reviewed and found to be on track. It is still early in the financial year so many of the budget headings do not yet have any recorded transactions.

I can confirm that, in my opinion, there are no matters that give rise to concern in the accounts from 1st April 2025 to 30th June 2025.
